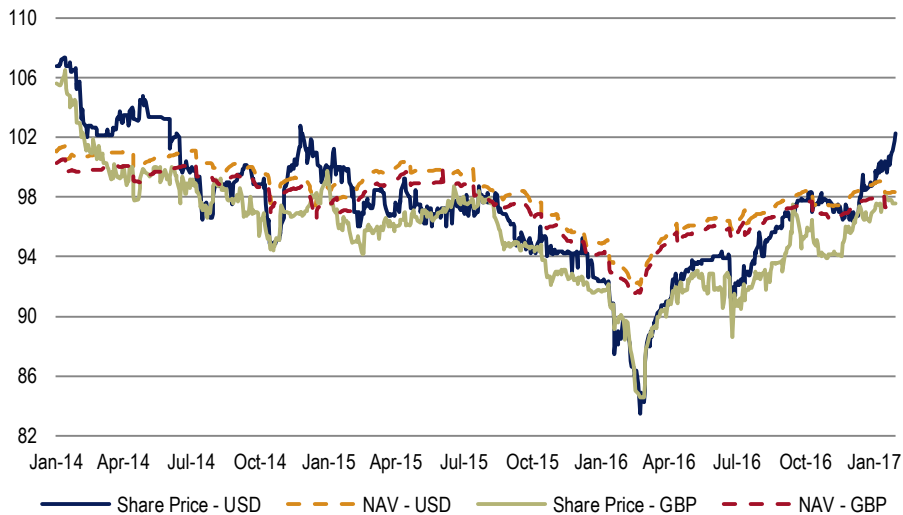

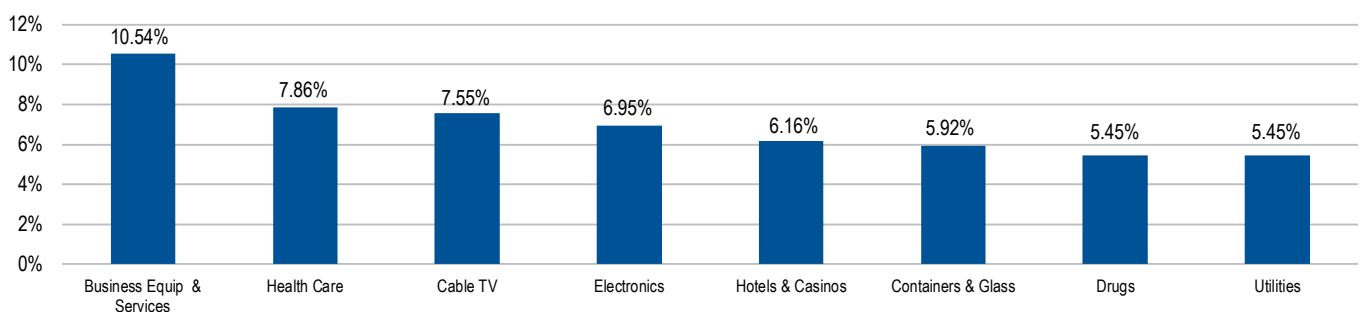

TOP 10 S&P SECTORS (ex Cash)



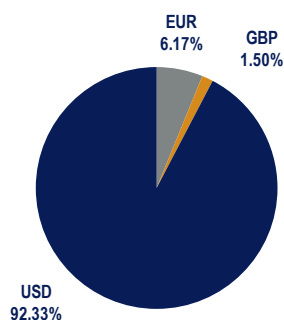

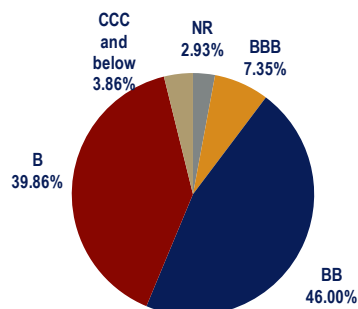

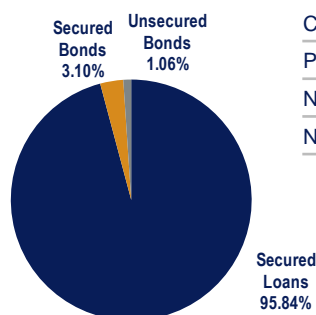
CURRENCY BREAKDOWN
